ORDER OF FINAL JUDGMENT

WHEREAS, Plaintiff has filed a legal action with this Court alleging violations of Michigan's *Freedom of Information Act* (FOIA) and violated Plaintiff's right to constitutional equal protection.

WHEREAS, Plaintiff has accepted the entry of Defendant's offer of judgment pursuant to MCR 2.405(C) with copy of the offer and notice of acceptance filed with the Clerk of the Court.

WHEREAS, this offer was made as a compromise of a disputed claim, and not as an admission of liability, fault, or violation of Plaintiff's federal civil rights under 42 USC§ 1983, his rights under the Michigan Freedom of Information Act or the laws of the State of Michigan.

NOW, THEREFORE, IT IS ORDERED AND ADJUDGED THAT:

1. Judgment is hereby entered in favor of Plaintiff against Defendant, with the Court ordering that Defendant shall—
 - a. provide Plaintiff with all mugshots of people arrested and charged from January 1, 2016 through January 15, 2016, as requested in Plaintiff's January 21, 2016 FOIA request (copy of which is attached hereto); and
 - b. pay reasonable attorney fees, costs, and disbursements in the amount of \$3,000.00 inclusive of all damage claims of whatever nature that could be presented at trial, all attorney fees that could be awarded pursuant to 42 USC 1988, or any other statute, and all costs then accrued at the time of entry of a final judgment or order of dismissal.
2. This judgment is a final order and closes the case.

IT IS SO ORDERED.
